Annual General Meeting 2019 Results

Sydney – 30 May 2019: BrainChip Holdings Ltd (**ASX:BRN**), as required by ASX Listing Rule 3.13.2, advises that the results of the 2019 Annual General Meeting held today are as noted below and appended.

Resolution 1 was decided on a poll and passed by the requisite majority with the results of the poll as appended.

Advisory Resolution 1, Adoption of the Remuneration Report, had less than 25% of the votes cast against the resolution. As a result Resolution 9 (Spill Resolution) was not put to the meeting.

The balance of the resolutions were decided by a show of hands in the requisite majority with the proxy results received prior to the meeting as appended.
