nib holdings limited issue of Performance Rights

nib holdings limited ("nib") has today issued 9,511 Performance Rights to an employee pursuant to nib's Long Term Incentive Plan ("LTIP") for the performance period commencing on 1 July 2018 and ending on 30 June 2022.

The Performance Rights have a nil exercise price and an expiry date of 1 September 2022. The Performance Rights are subject to vesting conditions based on Underlying Operating Profit growth targets. The performance measurement period for the Performance Rights begins on 1 July 2018 and ends on 30 June 2022. If the Performance Rights vest and are exercised, the employee will become entitled to receive one ordinary nib share ("Share") for each Performance Right. A two year non-disposal period applies to 50% of the Shares allocated on the vesting and exercise of the Performance Rights.

Following this issue of Performance Rights as well as the forfeiture of 55,436 performance rights for a previous LTIP participant, nib will have the following unquoted securities on issue:

2,390,899 Performance Rights in total, comprising:

- 628,895 Performance Rights expiring 1 September 2019;
- 581,315 Performance Rights expiring 1 September 2020;
- 631,092 Performance Rights expiring 1 September 2021; and

The number of shares on issue will not change as a result of the issuance of the performance rights and it is not expected that the number of shares on issue will change if the performance rights are exercised. nib will inform the market of how many of the employee's Performance Rights vest and are exercised and will confirm if Shares are bought on-market or issued to fulfil nib's obligations under the Performance Rights. Currently, nib intends to fulfil its obligations by purchasing Shares on-market.
