ISSUE OF SHARES – S708A CLEANSING NOTICE

Dreadnought Resources Limited (ASX:DRE, “Dreadnought” or the “Company”) advises that it has issued 51,559,604 fully paid ordinary shares at an issue price of \$0.004 to Calm Holdings Pty Ltd, Robert Anderson, Glenn Money and Drew Money (together the ‘sellers’) in lieu of 1,000,000 shares in IronRinger (Tarraji) Pty Ltd under an agreement to acquire the remaining 5.59% minority interest of the 94.41% owned entity from the sellers making it a 100% owned subsidiary.
