**NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT**

As announced on 17 April 2019, Aumake International Limited (ACN 150 110 017) (**Company**) completed a capital raising of A\$7,000,000 via the placement of 43,750,000 fully paid ordinary shares in the capital of the Company (**Shares**) at an issue price of \$0.16 per Share to institutional and sophisticated investors (**Placement**).

Quentin Flannery, a non-executive director of the Company, agreed to subscribe for 3,125,000 Shares under the Placement. The issue of the Shares to Mr Flannery was subject to shareholder approval.

At the Company's general meeting held on 27 June 2019, shareholders approved the issue of the Shares to Mr Flannery. Accordingly, on 2 July 2019 the Company issued 3,125,000 Shares to Mr Flannery to complete the Placement.
