APOLOGY from The Weekend Australian – July 6, 2019

ASF Group Limited (ASX:AFA) refers to the announcement made by us on 4 March 2019 concerning an article in the Weekend Australian newspaper dated March 2, 2019 where it was alleged that ASF Group participated in illegal activity relating to employment of two of its past employees.

These allegations (and others contained in the Article) were vigorously denied and are simply untrue – we claimed they were misleading and defamatory.

In the Weekend Australian on 6 July 2019 Nationwide News Pty Limited (a subsidiary of News Corporation) published the attached Apology withdrawing the offending Article referred to above.

In addition to the Apology the parties have settled the dispute on confidential terms.
