Dear NEW Optionholder

NEWOB Options to expire on 8 August 2019

We are writing to you as a registered holder of options (ASX: NEWOB) (**Optionholder**) in New Energy Solar (**Options**), a stapled entity comprised of New Energy Solar Fund (ARSN 609 154 298) and New Energy Solar Limited (ACN 609 396 983) (**NEW** or **we/us**). Your Options will expire at 5:00pm (AEST) on 8 August 2019 if not exercised prior to that time and date, however Optionholders are not required to exercise their Options. Options are exercisable at \$1.60 per Option. The closing price for NEW was \$1.265 on 8 July 2019, being the last trading day prior to the date of this notice. Under paragraph 6.1 of Appendix 6A of the Australian Securities Exchange (ASX) Listing Rules, NEW is required to advise Optionholders of the information contained in this notice.

Your Options may be exercised in whole or in multiples of 5,000 in the manner described below by no later than 5:00pm (AEST) on 8 August 2019. Any Options not validly exercised by that time will lapse and all rights under those Options will cease at that time.

You may do any of the following:

- (a) Do nothing (i.e. allow your Options to expire). If you do not exercise or sell your Options, they will expire at 5:00pm (AEST) on 8 August 2019 and your right to subscribe for stapled securities in NEW at an exercise price of \$1.60 per stapled security will lapse. It is important to note that the closing price for NEW was \$1.265 on 8 July 2019, being the last trading day prior to the date of this notice and securities could be purchased at lower cost on market than through exercising your Options;
- (b) Sell your Options. Quotation of the Options will cease at the close of trading on 2 August 2019; or
- (c) Exercise your Options. If you wish to exercise your Options at the exercise price of \$1.60 per Option, please complete the enclosed "Notice of Exercise of Options" Form and send it together with payment in accordance with the instructions set out on the form. You may only exercise your Options in multiples of 5,000 unless you are exercising all of your Options. Your completed notice and payment (in clear funds) must be received by no later than 5:00pm (AEST) on 8 August 2019. If we do not receive your payment in clear funds by this time then your Options will expire.
