## InvoCare announces the acquisition of Australian Heritage Funerals, Toowoomba Queensland

InvoCare Limited (ASX: IVC) is pleased to announce it has entered into a conditional purchase agreement to acquire Australian Heritage Funerals located in Toowoomba Queensland. The proposed acquisition is anticipated to complete by the end of the month.

Australian Heritage Funerals represents an opportunity for InvoCare to expand its presence in a regional market where it currently operates under the Hiram Philp Funerals brand and also the Toowoomba Garden of Remembrance memorial park.

Australian Heritage Funerals is a highly successful business in the region, performing circa 300 funerals, per annum and generating annual revenue of approximately AU\$2 million. The business was established in 1998 by the McGrath-Colquhoun family and is managed by Judith McGrath-Colquhoun. As a fifth generation Darling Downs family, the team have a long, established history in the region.

The acquisition includes a long term lease over the existing funeral home, mortuary and chapel. The facilities will also be used to support InvoCare's current businesses in the Toowoomba region.

Martin Earp, InvoCare's Chief Executive Officer and Managing Director said: "InvoCare through the Toowoomba Garden of Remembrance has enjoyed a very productive working relationship with the Australian Heritage Funerals team and have met the needs of a large number of Toowoomba families over very many years.
