Corporate Update – Perth Sale and Entitlement Offer Extension

Indoor Skydive Australia Group Limited (ASX:IDZ) (**ISA Group**) provides the following update to the sale of the Perth Indoor Skydiving assets and the extension of the closing date for the Entitlement Offer.

Perth Assets Sale

The sale transaction is progressing well between the two parties with the due diligence phase over 90% complete and the draft asset sale agreement underway.

Both parties are now aiming to finalise and execute the asset sale agreement on or around the 2nd week of August 2019 with completion of the sale to occur following satisfaction of any conditions to the asset sale.

SkyVenture have commenced the handover process, with their startup operations team scheduled to land in Australia in mid- August.

The closing date for the Entitlement Offer has been extended by 5 business days to 5.00pm (Sydney time) Thursday, 8th August 2019.

The extension of the closing date, originally falling on 1 August 2019, will allow eligible shareholders additional time to complete their application and participate in the Entitlement Offer following receipt of offer documentation.
