Completion of Share Placement – Appendix 3B and Cleansing Notice

Simble Solutions Limited (**Simble** or **the Company**) is pleased to confirm the issue of 25,812,083 ordinary fully paid shares pursuant to a placement announced to the ASX on 24 July 2019.

In accordance with ASX Listing Rules 7.1A.4(b) and 3.10.5A, the Company makes the following disclosures in respect of the Placement Shares:

- a) The dilutive effect of the Placement Shares on existing shareholders is as follows

- b) The Company issued the Placement Shares to professional and sophisticated investors as this was considered to be the most appropriate mechanism to raise funds in a timely manner and to meet the working capital requirements of the Company.
- c) No underwriting agreements were in place in respect of the Placement
- d) Paterson Securities Ltd and PAC Partners Pty Ltd acted as Joint Lead Managers (**JLM**) to the Placement and will be paid a fee of 6% of the gross funds raised under the Placement. The JLM will also be issued a total of 3 million broker options (**Broker Options**), subject to shareholder approval. Each Broker Option is exercisable at a price of \$0.15 into one share for a period of 24 months following the date of the issuance.

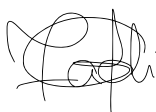
On 24 July 2019 Simble Solutions Limited (or The Company) (ASX:SIS), announced a placement of 15,487,250 shares under ASX Listing Rule 7.1 and a further 10,324,833 shares under ASX Listing Rule 7.1A. with up to a further 12,000,000 shares to be issued subject to Shareholder approval following a General Meeting of the Company.
