Takeover Bid for CBG Capital Limited - Fulfilment of certain defeating conditions

Clime Capital Limited (ASX:CAM) (**CAM**) announces that the takeover offer to acquire the shares in CBG Capital Limited (ASX:CBC) (**CBG**) is free from the defeating condition in section 14.8(a)(vi) (no prescribed occurrences between Announcement Date and date of Bidder's Statement), which was fulfilled on the date the Bidder's Statement was given to CBG, being 19 July 2019.

Attached to this announcement is a Notice of Fulfillment of Defeating Conditions pursuant to section 630(4) and section 630(5)(b) of the *Corporations Act 2001* (Cth).

CAM notes that the CBG Independent Directors have recommended that CBG shareholders ACCEPT the offer in the absence of a superior proposal.
