Construction Materials and Services provider, Wagners Holding Company Limited (ASX:WGN) today released its results for the financial year ending 30 June 2019.

Financial Performance

- Revenue of \$236.9 million
- Pro forma EBIT result of \$25.6 million
- Pro forma NPAT of \$13.6 million
- Board has elected not to declare a final dividend

Operational Update

Construction Materials and Services

- Significant investment in our concrete plant network leading to an increase in operating costs as we expand the business in SEQ.
- Large infrastructure projects have been delayed, impacting financial performance in this area.
- Transport division delivered increased earnings through execution of long-term contracts, revenue increase greater than 200%.
- Lower cement volume due to our dispute with Boral has negatively impacted both revenue and EBIT.

New Generation Building Materials

- Record production of composite fibre crossarms from our Toowoomba Composite Fibre Technologies (CFT) manufacturing facility.
- CFT pultrusion machine manufactured and ready for deployment to the USA.
- Continued investment into Earth Friendly Concrete (EFC).

Wagners CEO, Cameron Coleman said, "Whilst there are some challenges in the SEQ construction materials sector, we remain committed to delivering our strategy to increase our presence in the concrete market with the establishment of new batching plants with Earth Friendly Concrete (EFC) capability, and look forward to the contributions our Composite Fibre Technologies (CFT) business will provide as we establish our manufacturing center in the USA."
