REQUEST FOR SUSPENSION OF SECURITIES

Moreton Resources Limited requests a Suspension of the Company's securities from official quotation, to take effect immediately.

The basis of the request by the Company is the following:

Reason for the Suspension.

The Company is still working through its final position upon the makeup of the Board, to ensure it is compliant with the relevant listing rules.

Further to this, the Company is awaiting material information, pertaining to the Court Proceedings relevant to the Financial Assurance, that in the boards view may have a material affect upon the next phase of the operations, and we expect further information on this matter early next week.

The Company awaits confirmation from its Legal advisors, upon the agreement or otherwise, of the outcome of the Federal Court Orders and next steps required for the Research and Development Claims outstanding for Moreton Resources Limited, post the favourable outcome of the Federal Court Ruling. The Company is unsure if the matter will be run again in the AAT or if the parties are able to resolve the matters but is expected to be in a better position to update the market next week.

How long the suspension is expected to last.

The suspension is expected to last no longer than, until the commencement of trade upon the 2nd of September 2019.
