In accordance with the Rules of the DRP, the VWAP during the pricing period was 91.43 cents per share, and issue price of shares under the DRP was **86.8585 cents per share** after adjusting for the 5% discount.

The Board of Eumundi Group is pleased with the continued high level of participation by shareholders in the DRP which was again in excess of 96%.


