ANTAM REFINANCES US\$129 MILLION CORPORATE INVESTMENT LOAN THROUGH LOAN INVESTMENT FACILITY FROM BANK MANDIRI

Jakarta, September 18, 2019 – PT ANTAM Tbk (ASX: ATM, IDX: ANTM, ANTAM) and PT Bank Mandiri (Persero) Tbk (IDX: BMRI, Bank Mandiri) are pleased to announce the both company has conducted cooperation in finance area through the signing of corporate investment loan agreement from Bank Mandiri to refinance ANTAM's US\$129 million investment loan which will mature on June 2024. ANTAM refinances its current loan with a similar loan provision and having more competitive annual floating interest rate.
