**Adelaide, Australia, Friday 18 October 2019: Axiom Properties Limited (ASX:AXI)** lodges the attached Appendix 4C Quarterly report for entities admitted on the basis of commitments for the quarter ended 30 September 2019.

Commentary is provided as follows:

- The Company held cash reserves of \$8.135 million at 30 September 2019.
- The Company's cash reserves for the September quarter decreased by \$1.071m as follows:
  - o Net operating cash outflows for the September quarter were \$1.079m.
  - o Net investing cash inflows for the September quarter were \$8,020.
  - o Nil financing cash flows for the September quarter.

The Company continues to strategically deploy its capital in its property portfolio including its Double Bay project in Sydney, Currie Street project in Adelaide and Butler Central project in Perth, as well as investigating new opportunities expected to generate superior returns.
