2. Resolution 1 – Remuneration Report

To consider and if thought fit to pass the following resolution as an ordinary resolution:

"To adopt the Remuneration Report of the Company for the year ended 30 June 2019."

3. Resolution 2 – Election of Director

To consider and if thought fit to pass the following resolution as an ordinary resolution:

"That Bill Best, who retires as a Director pursuant to the requirement in ASX Listing Rule 14.5 and section 63 of the Company's Constitution and being eligible be elected as a Non-executive Director."

The Board (with Mr Best abstaining in respect of this resolution) recommends the election of Mr Best.

4. Questions and comments

Shareholders will be given a reasonable opportunity to ask questions about or comment on the Company's activities and the audit of the Company.

GENERAL INFORMATION

Voting Entitlements

The Company has determined that in accordance with regulation 7.11.37 of the Corporations Regulations 2001 (Cth) that for the purposes of the AGM (including voting), shares will be taken to be held by those persons recorded in the Company's register as at 2pm Wednesday 27 November 2019 (AEDT).

Proxies

A shareholder entitled to attend and vote at the AGM is entitled to appoint not more than two proxies, who need not be members of the Company. Where more than one proxy is appointed, each proxy should be appointed to represent a specified percentage or specified number of the shareholder's voting rights. If the appointments do not specify the percentage or number of votes that each proxy may exercise, each proxy may exercise half the votes.

Fractions of votes will be disregarded.

A Proxy Form accompanies this Notice of AGM.

To be valid, online proxy voting or the completed Proxy Form must be submitted at least 48 hours before the time for holding the meeting (i.e. by no later than 2pm (AEDT) on Wednesday, 27 November 2019) using one of the following methods:

Voting by Attorney

Corporations

A corporation that is a shareholder or a proxy may elect to appoint a representative in accordance with the Corporations Act 2001 (Cth), in which case the Company will require written proof of the representative's appointment, which must be lodged with or presented to the Company before the commencement of the AGM.

Registration

If you are attending the AGM in person, please bring the personalised Proxy Form enclosed with this Notice of AGM with you to facilitate registration. If you do not bring the Proxy Form with you, you will still be able to attend the AGM, but at registration, our representatives will need to

verify your identity. Registration will be available from 1:00 pm (AEDT) on the day of the AGM.

EXPLANATORY NOTES

These Explanatory Notes have been included to provide information about the items of business to be considered at the Company's AGM to be held on Friday, 29 November 2019 at 2pm (AEDT).

1. Financial Statements and Reports

As required by section 317 of the Corporations Act 2001 (Cth), the Company's Financial Statements, Directors' Report and Auditor's Report will be presented for consideration. No resolution is required for this item, but shareholders will be given the opportunity to ask questions and to make comments on all aspects of these reports. Shareholders will also have a reasonable opportunity to ask the Auditor questions relevant to the conduct of the audit and the preparation and content of the Independent Audit Report.

2. Remuneration Report

A resolution for the adoption of the Remuneration Report must be considered and voted on in accordance with section 250R(2) of the Corporations Act 2001 (Cth).

The Remuneration Report forms part of the Directors' Report in the Company's Annual Report. The Remuneration Report details the Company's policy on the remuneration of its Directors. The vote on the adoption of the Remuneration Report resolution is advisory only and does not bind the Directors or the Company. However, the Board will take the outcome of the vote into consideration when reviewing the remuneration practices and policies of the Company.

The Board recommends that shareholders vote in favour of the adoption of the Remuneration Report. The Chairman of the meeting intends to vote all available proxies in favour of the adoption of the Remuneration Report.

Voting Exclusion Statement

The Company will disregard any votes cast on this Resolution by, or on behalf of:

- ☐ a member of the key management personnel (KMP), as disclosed in the Remuneration Report; and
- ☐ their closely related parties, unless the vote is cast:
- ☐ by a person as proxy for a person entitled to vote in accordance with a direction on the Proxy Form; or
- ☐ by the Chairman of the Meeting as proxy for a person entitled to vote and the Chairman has received express authority to vote undirected proxies as the Chairman sees fit.

3. Election of Bill Best

Bill Best retires in accordance with ASX Listing Rule 14.5 and clause 63 of the Company's Constitution and, being eligible, offers himself for election as an independent non-executive director. Mr Best was originally appointed to the Board effective 14th December 2018.

Bill brings more than 30 years of investment, advisory and capital markets experience. Bill is currently Chairman of Inala, an organisation supporting individuals with disabilities, Chairman of Liverpool Partners and acts as an advisor to On Market Bookbuilds. Bill is also a director of Pyrolyx AG and the Australian Chamber Orchestra. He was previously Chairman of LifeHealthcare Limited and an Executive Director of Macquarie Bank. Bill has LLB, B.Comm and M.Comm degrees.

The Board (other than the relevant Director in relation to his own election) recommends the election of Mr Best.

The Chairman of the Meeting intends to vote undirected proxies in favour of the election of Mr Best.

In addition to any questions asked or comments made in relation to the specific items of business, the Chairman will give shareholders a reasonable opportunity to ask questions about or comment on the activities of the Company.






