Key Financial Information

Appendix 4C, which has been prepared in U.S. dollars under U.S. GAAP, is attached and the results disclosed in Appendix 4C are unaudited. The Company plans to file its Quarterly Report on Form 10-Q with the U.S. Securities and Exchange Commission and the Australian Securities Exchange on or before 14 November 2019. Form 10-Q will provide financial statements for the quarterly period ended 30 September 2019, along with management's discussion and analysis of financial condition and results of operations.

As of 30 September 2019, the Company had cash and cash equivalents of \$1.4 million compared to \$2.4 million on 30 June 2019. The change in the cash and cash equivalents balance for the quarter is primarily comprised of \$3 million of net cash used in operating activities offset by net cash from financing activities of \$2 million.

GI Dynamics®, Inc. (ASX:GID) is the developer of EndoBarrier®, the first endoscopically-delivered device therapy for the treatment of type 2 diabetes and obesity. EndoBarrier is not approved for sale and is limited by federal law to investigational use only. EndoBarrier is subject to an Investigational Device Exemption by the FDA in the United States and is entering concurrent pivotal trials in the United States and India.
