Launch of UKIIC, London – November 2019

ASF Group Limited (ASX:AFA) through its wholly owned UK subsidiary BSF International Ltd launched a new initiative in the UK to join with Cocoon Global in the City of London to develop an incubation Centre for development of early stage technology and life science businesses.

The International Innovation Alliance (**IIA**) and the UK International Innovation Centre (**UKIIC**) was launched jointly founded by BSF International Ltd and Magna Carta Island International Innovation Centre in Cocoon Global offices in 4 Christopher Street, London, UK.

Ms. Min Yang, Executive Chairman of ASF and BSF International Ltd will serve as Chairman of the International Innovation Alliance and the Chairman of the UKIIC. The IIA will set up UKIIC in a number of countries and cities to integrate resources to promote technology investment, the transformation of research and development results, and the integration of academia and industry. The UKIIC is the headquarters of the IIA in the UK and is based in Cocoon Global.

The IIA's goal is to integrate Chinese and English innovations, meet the constructive needs of intellectual property protection, integrate into the global innovation network, and promote the exchange and cooperation of scientific research personnel, and promote the high-quality development of high-tech industries and the high-efficiency operation of high-tech enterprises.
