**OncoSil provides positive CE Mark update**

**Sydney, Australia – 19 November 2019:** OncoSil Medical Ltd (ASX: OSL) (**OncoSil** or the **Company**), a medical device company focused on localised treatments for patients with pancreatic and liver cancer, wishes to provides an update on its CE Marking review following a meeting with BSI Management on 14 November.

**CE Mark update**

OncoSil is pleased to report that the company held a positive and constructive meeting with BSI Management relating to the Company’s Post Market Surveillance (PMS) Plan and Post Market Clinical Follow-up (PMCF) programme.

Based on the discussions held the Company will now formally submit the OncoSil™ device PMS and PMCF plans to BSI for final review.

These post approval plans outline the compliance regimen associated with the European roll out of the OncoSil™ device in the treatment of unresectable locally advanced pancreatic cancer. Based on positive progress to date the Company will now finalise its commercialisation plans in anticipation of CE Marking approval in the coming months.

“The presentation of the Company’s PMS/PMCF plans was well received. Based on the discussions held we will now finalise these plans and submit to BSI as soon as possible. We are delighted with the continuing progress with our CE Marking submission” said CEO Daniel Kenny

The Company will continue to keep the market informed of developments during the final phase of the review.

**About OncoSil**

OncoSil Medical is a medical device company seeking to advance radiation for cancer patients. OncoSil Medical’s lead product, OncoSil™ is a targeted radioactive isotope (Phosphorus-32), implanted directly into a patient’s pancreatic tumours via an endoscopic ultrasound.

Treatment with the OncoSil™ is intended to deliver more concentrated and localised beta radiation compared to external beam radiation. OncoSil Medical has conducted four clinical studies with

encouraging results on tolerability, safety and efficacy. A CE Mark application to commercially sell OncoSil™ in the European Union (EU) is under review.

The U.S Food and Drug Administration granted an Investigational Device Exemption (IDE) in July 2016 with approval to conduct a clinical study of the OncoSil™ device. The aim of the study will be to collect safety and effectiveness data required to support a Premarket Approval (PMA) application.

An Investigational Device Exemption (IDE) has been granted by the United States Food and Drug Administration (FDA) to conduct a clinical study of the OncoSil™ device aimed at supporting a PMA approval. Pancreatic cancer is typically diagnosed at a later stage, when there is a poor prognosis for long-term survival. The World Cancer Research Fund estimated that in 2012, 338,000 people globally were diagnosed with pancreatic cancer. The prognosis for patients diagnosed with pancreatic cancer, regardless of stage, is generally poor; the relative five-year survival rate for all stages combined is approximately 5%. The estimated world- wide market opportunity for OncoSil™ in pancreatic cancer exceeds \$1b.

Hepatocellular carcinoma (HCC) or liver cancer, is the 6th most common cancer in the world with 782,000 new cases diagnosed in 2012. While hepatocellular carcinoma can be treated by surgery or transplantation, the majority of patients with HCC have disease which is too advanced for surgery and their survival ranges from a few months to two or more years. The value of the hepatocellular cancer market is expected to triple in size to \$1.4b by 2019.
