Garda Holdings Limited – Admission and Commencement of Official Quotation of Stapled Securities in Garda Property Group

Description

Garda Diversified Property Fund (the 'Fund') is currently admitted to the Official List of ASX Limited ('ASX') and trades under the ASX code GDF.

On 1 November 2019, unitholders of the Fund approved resolutions to internalise the management of the Fund, whereby each share in Garda Holdings Limited (the 'Company') will be stapled to each unit in the Fund, following which the new stapled entity will acquire ASX listed stapled entity Garda Capital Group (ASX Code: GCM) comprising Garda Capital Limited and Garda Capital Trust by way of scheme of arrangement under Part 5.1 of the Corporations Act 2001 (Cth) and trust scheme (the 'Internalisation Proposal').

After implementation of the Internalisation Proposal, each existing unitholder of the Fund and stapled securityholder of GCM will hold a new stapled security each comprising of one fully paid ordinary unit in the Fund and one fully paid ordinary share in the Company ('Stapled Securities').

The Company is expected to be admitted to the Official List of ASX on Wednesday, 20 November 2019 at which point the new stapled entity will trade as Garda Property Group.

Official quotation of the Stapled Securities is expected to commence on a deferred settlement basis as part of Group 3 at 10:04:30 am +/- 15 seconds AEDT on Wednesday, 20 November 2019.
