- The September Quarter, is historically the weakest period across the entire automotive industry; however, we have seen a strong recovery in October -November

RPMAG has begun actioning our plan to grow the business with the acquisitions of The Hallam Tyre Retail Store as well as our recent announcement – Elite Tyre Group and Super Tyre Mart.

Dale Sinnott, RPMAG CFO was quoted saying, "Our current results, achieved in soft trading conditions, in the aftermath of the RTO, have laid the foundations for the Group to achieve its forecast returns. We also find ourselves in a strong position to integrate these new businesses into our infrastructure, creating opportunities and economies of scale across the RPMAG"
