Changes in Equity Securities

Advanced Australian lithium developer Core Lithium Ltd (Core or Company) (ASX: CXO) advises the following changes in securities of the Company:

- Issue of 100,000 fully paid ordinary shares upon exercise of unquoted performance rights by an employee following vesting of rights where performance conditions have been met;
- Issue of 13,000,000 unquoted performance rights to the Managing Director as remuneration under the Company's Performance Share Plan;
- Issue of 5,000,000 unquoted options to each of the four directors of the Company as remuneration under the Company's Share Option Plan; and
- Lapse of 200,000 unquoted performance rights where the performance based vesting conditions were not met.

The issue of director options and rights was approved by shareholders at the Company's 2019 AGM. All other securities are issued under an exception under Listing Rule 7.2.

An Appendix 3B seeking quotation of the shares is attached to this announcement.

Core notes that the results of the 2019 AGM were lodged as an announcement on 28 November 2019. The text adjacent Resolution 15 should have read "Approval of proportional takeover provisions" in tables 1 and 2. All other details (including proxy and poll votes) remain unchanged.
