I refer to the changes to the Board of Directors of Xanadu Mines Ltd (ASX:XAM) (Xanadu Mines or the Company) as set out in the Company's ASX Announcements dated:

- 18 October 2019, advising the resignation of Ms. Hannah Badenach as a non-executive director, the appointment of Mr. Stephen Motteram as a non-executive director of the Company, with effect from 1 November 2019; and
