# Limeade, Inc. (ASX: LME) – Admission and Commencement of Official Quotation

## **Description**

Limeade, Inc. ('LME') is expected to be admitted to the Official List of ASX Limited ('ASX') either in the afternoon of Thursday, 19 December 2019 or on the morning of Friday, 20 December 2019.

LME raised \$100.0 million pursuant to the offer under its prospectus dated 2 December 2019 ('Prospectus') by the issue of 27,060,208 CDIs and sale and transfer of 26,993,846 CDIs at an issue and sale price of \$1.85 per CDI.
