Advanced Australian lithium developer Core Lithium Ltd (Core or Company) (ASX: CXO) advises the following changes in securities of the Company:

- Issue of 450,000 fully paid ordinary shares upon exercise of unquoted performance rights by employees following vesting of rights where performance conditions have been met;
- Issue of 392,156 fully paid ordinary shares as consideration for professional services as approved by shareholders at the 2019 AGM;
- Issue of 11,950,000 unquoted performance rights to employees of the Company as remuneration under the Company's Performance Share Plan; and
- Lapse of 1,200,000 unquoted performance rights where the performance based vesting conditions were not met.
