



## ASX ANNOUNCEMENT (UWL)

### Settlement of Retail Entitlement Offer & Appendix 3B

**27 December 2019**, Uniti Group Limited (ASX: UWL) is pleased to advise that it has today settled and issued shares under the retail component (**Retail Entitlement Offer**) of the underwritten accelerated non-renounceable entitlement offer (**Entitlement Offer**) as announced on 3 December 2019.

Attached is an updated Appendix 3B, detailing new securities issued in the Retail Entitlement Offer.

The Board is pleased to advise the total amount of \$84.9 million sought to be raised through a placement and Entitlement Offer has now been completed successfully, in full. These proceeds were used to settle the acquisition of 1300 Australia (and associated transaction costs), with the remainder being added to the Company's cash reserves, increasing UWL's net cash-at-bank to in excess of \$27 million.

The abovementioned \$84.9 million raised under the placement and Entitlement Offer was comprised of \$27.71 million from the accelerated institutional component of the Entitlement Offer (as announced on 5 December 2019), \$14.25 million from the Retail Entitlement Offer (as announced on 24 December 2019) and \$42.94 million from the placement conducted concurrently with the accelerated institutional component of the Entitlement Offer.

This release is approved by the Board of Directors of Uniti Group Limited.
