The Fund will reopen for applications and redemptions by Authorised Participants on 02 January 2020. The above close period arrangements are not applicable for EINC & RINC.

You must be registered as a unitholder of the Funds as of the Record Date to be eligible to receive a distribution. To be eligible, you will need to have purchased your units prior to the Ex Distribution Date, for the transaction to have been settled and for your unitholding to have been entered on the register as of the Record Date.

For eligible unitholders, the Distribution Reinvestment Plan ("DRP") is operating for each Fund. Any DRP elections must be received by the registrar, Link Market Services, by 06 January 2020.
