Trade Finance Loan Book & Compliance as at 31 Dec 2019

In accordance with the Corporate Bond Issue Information Memorandums released to the ASX on 18 May 2015, CML Group (ASX code: CGR) wish to advise that as at 31 Dec 2019 it was compliant with all Financial Covenants contained within the Memorandums. The calculations are tabled below.

The purpose of this release is to confirm compliance with Corporate Bond Covenants, which is now a small component of CML's funding pool and should not be relied upon as an indicator of business volume or overall performance.

At the end of Dec 2019 CML had a trade finance loan book funded by Corporate Bonds of over \$45.5m (Nov 2019: \$54.2m), of which it had supplied actual funding of \$25.4m (Nov 2019: \$24.4m). This represents a Loan to Value ratio of 55.9% (Nov 2019: 45.0%).

Please note all Financial Covenant definitions are contained in the Information Memorandum released to the ASX on 18 May 2015.
