Answer: Yes, the company announced on 16 December 2019 that it had received a number of indicative, non-binding and confidential non-dilutionary funding proposals with respect to both short and/or long-term financing arrangements. One of these funding proposals is from the company's major shareholder and lender, OCP Asia (Singapore) Pte Ltd ("OCP"), which would provide funding of up to \$4 million. Whilst there can't be any guarantees that funding will be secured, OCP have a history of supporting the company's fundraising activities and it is therefore believed to be likely to succeed.

- Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?
