Answer: No. Revised DFS and EIS on the Company's Authier project has been completed and is now progressing through the permitting process. Expenditure commitment is expected to reduce.

Level of expenditure over the future quarters will be determined by the progress of the NAL process.

- Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Yes. During the period, the Company entered into a Controlled Placement Agreement (CPA). The CPA provides Sayona with up to \$3 million of standby equity capital. Subsequent to quarter end, the Company secured a convertible note facility of up to \$2.75 million.

- Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes, funding initiatives have been put in place and additional options are reviewed from time to time.
