# **Resignation of director: Phillip Kingston**

With the handover now complete, Phillip has decided that the time is right for him to step down from the board."

Founder and outgoing Non-Executive Director, Phillip Kingston, added: "It has been a privilege to serve alongside my fellow directors and the hugely talented group of people working across GrowthOps. I continue to believe in the Company's founding thesis, and am now firmly of the view that the Company, led by Clint Cooper, with guidance from Scott and the rest of the board, is in extremely capable hands to deliver on the promise of GrowthOps. As I enter a busy period related to my other business interests, and with my handover now complete, the timing is right for my resignation from the board. Although now in a less formal capacity, I look forward to continuing to support the Company."
