360 Capital Group (ASX:TGP) (Group) is pleased to announce that 360 Capital Equities Management Pty Limited has entered into a binding agreement to purchase Ralton Asset Management (Ralton) and establish a Melbourne office for the Ralton and Cambridge Investment Partners teams.

Ralton is a leading Australian equity managed accounts specialist. Established in 2005 it has been built focused on providing separately managed accounts (SMAs) and individually managed accounts (IMAs) for individual investors and institutions.

Ralton will continue to operate its current investment business under 360 Capital ownership, including its four Australian Equity SMA strategies with no plans to change the current suite of products.

Will Riggall (Portfolio Manager) and Andrew Garside (Investment Analyst /Dealer) will continue with Ralton under the new structure in the same roles ensuring continuity.

Dennison Hambling and Fleur Graves, current members of the 360 Capital equity investment team will join the Ralton team and support Will Riggall in managing the equity portfolios. Hambling and Graves have 22 and 12 years' successful experience in equity investing through MDA/IMA structures.

Post completion of the Ralton acquisition, 360 Capital's FUM increases to over \$600m, its investor base increases to over 18,000 investors with products currently on 9 wrap platforms.

"We are very excited by the acquisition of Ralton and gratified by the initial feedback and support shown by existing clients, ratings agencies and platforms.
