CORRECTION OF FORM 603 NOTICE AND LODGEMENT OF FORM 604 NOTICE IN PENGANA PRIVATE EQUITY TRUST (PE1)

As a result of the review of historical data, Westpac Banking Corporation (WBC) has become aware that:

1. Revised Initial Substantial Holder Notice

Its notice dated 1 May 2019 notifying that it had become a substantial holder in Pengana Private Equity Trust (PE1) overstated the relevant interests of WBC and its related entities in PE1. A revised substantial holder notice for WBC is enclosed, which corrects the percentage unitholding disclosed in the previous Form 603, the class of securities, and the date on which WBC became a substantial holder in PE1.

- (5) The person's votes divided by the total votes in the body corporate scheme multiplied by 100.
- (6) Include details of:

If subsection 671B(4) applies, a copy of any document setting out the terms of any relevant agreement, and a statement by the person giving full and accurate details of any contract, scheme or arrangement, must accompany this form, together with a written statement certifying this contract, scheme or arrangement; and
 - (b) any qualification of the power of a person to exercise, control the exercise of, or influence the exercise of, the voting powers or disposal of the securities to which the relevant interest relates (indicating clearly the particular securities to which the qualification applies).

See the definition of "relevant agreement" in section 9 of the Corporations Act 2001.

- (7) Details of the consideration must include any and all benefits, money and other, that any person from whom a relevant interest was acquired has, or may, become entitled to receive in relation to that acquisition. Details must be included even if the benefit is conditional on the happening or not of a contingency. Details must be included of any benefit paid on behalf of the substantial holder or its associate in relation to the acquisitions, even if they are not paid directly to the person from whom the relevant interest was acquired.
