We advise **131,586 Performance Rights (NANAO)** have been granted under the Nanosonics Omnibus Equity Plan. Since 9 December 2019, there have been a total of 2,899 Performance Rights (NANAO) and 39,788 Options (NANAB) which were forfeited.
