### Net Tangible Asset (NTA) backing per share at 29 February 2020

The unaudited NTA backing per share of the Company at 29 February 2020 was as follows:

The NTA figures shown above are before and after the provision for deferred tax on the unrealised gains in the Company's investment portfolio. The Company is a long-term equity investor and does not intend to dispose of its total portfolio. During February 2020, all markets were adversely affected when the outbreak of the Coronavirus was reported and spread globally rapidly.

The market value (in US Dollars) of Berkshire Hathaway shares on the New York Stock Exchange decreased compared to the previous month-end. In addition, the Australian Dollar was weaker against the US dollar at month-end. The market value of the UK Portfolio decreased in value over the month and the value of the Australian dollar increased marginally against the GBP. The share price of Athelney Trust plc listed on LSE decreased in value. Flagship Investments Ltd (FSI) listed on the ASX, decreased in value during February 2020. The unit price of BCI Worldwide Fund decreased marginally at month end. The overall effect of the above was a decrease in the Net Tangible Asset Backing per share of Global Masters Fund Limited at 29 February 2020.
