Invigor wins tender to supply data to WA's Economic Regulation Authority

- Invigor selected to supply alcoholic beverage pricing data to the Western Australian Economic Regulation Authority for their Container Deposit Scheme.
- Contract will deliver revenue in the range of \$100,000 to \$120,000 between March 2020 and July 2021.

Invigor Group Limited (ASX: IVO) ("**Invigor**" or "**the Company**") has successfully tendered and won a contract with the Western Australian Economic Regulation Authority (ERA) to supply alcoholic beverage pricing as part of the State's Container Deposit Scheme.

Invigor houses the largest pricing data base of alcoholic beverages across major retailers in Australia. Capturing online and offline pricing by retailer and by state the Company has previously supplied alcoholic beverage pricing as part of New South Wales State's Container Deposit Scheme.

The contract was won pursuant to a tender from the Western Australian Government on behalf of the ERA. The contract is for the supply of Invigor's Retail Pricing solution in respect of alcoholic beverages. Revenue in the range of \$100,000 - \$120,000 will be earnt during the period March 2020 to July 2021.

The terms of the contract are under the Western Australian Government as set out in the Schedule below.

The major terms of the contract are:

Contract Term: March 2020 to July 2021 with opportunity to extend and renew.

Payments Invoice Dates: March 2020 for initial set up fees, and instalments in July 2020, January 2021, and July 2021 following delivery of agreed data.

No Trial Period: The contract is not subject to a trial period or other conditions that are required to be satisfied before the parties proceed with the agreement.

The Contract is regulated by the Terms of supply to contracts of a similar nature by the Western Australian Government as set out in their General Conditions of Contract which can be viewed in detail from the following link:
