Please find attached an Appendix 2A relating to 2,091 ordinary shares in Brambles Limited which have been issued as a consequence of the vesting of matched share rights under the Brambles Limited MyShare Plan to former employees classified as “good leavers” under that plan and the exercise of share awards under the Brambles Limited Performance Share Plan. (Please note that 4,247 unlisted matched share rights granted under the Brambles Limited MyShare Plan have lapsed since the lodgement by Brambles of the Appendix 2A on 12 March 2020.)
