Due to the uncertainty surrounding the spread of Covid-19 globally, the Directors of Harvey Norman Holdings Limited announce that the aggregated written total and written comparable amount of sales from wholly-owned company-operated stores in New Zealand, Croatia, Ireland and Northern Ireland, majority-owned controlled company-operated stores in Singapore and Malaysia, and from independent Harvey Norman®, Domayne® and Joyce Mayne® branded franchised complexes, excluding commercial sales ("Aggregated Sales") for the period 1st March 2020 to 17th March 2020 compared to the period 1st March 2019 to 17th March 2019, are as follows:

By Government decree, the Slovenian stores have closed from 16<sup>th</sup> March 2020 until further notice from the Slovenian Government. Written total and written comparable sales from wholly owned company operated stores in Slovenia, in constant local currency, for the period 1<sup>st</sup> March 2020 to 14<sup>th</sup> March 2020 decreased by (-1.7%) compared to the corresponding prior year period. It should be noted retail in Slovenia does not trade on a Sunday.

By Government decree, the Malaysian stores have closed from 18th March 2020 to 31st March 2020.

By Government decree, the Croatian store has closed from 19th March 2020 for a period of 30 days.

The wholly owned company operated stores in New Zealand, Ireland, Northern Ireland and Singapore and the independent Harvey Norman®, Domayne® and Joyce Mayne® branded franchised complexes in Australia are open for business as usual.

The Company is taking steps to ensure the health and safety of employees and customers.
