Request for Trading Halt pursuant to ASX Listing Rule 17.1

Pursuant to ASX Listing Rule 17.1, Redcape Hotel Group Management Ltd, as responsible entity of the Redcape Hotel Group (**ASX:RDC**) requests a Trading Halt be granted by the Australian Securities Exchange in respect of its securities immediately.

For the purposes of ASX Listing Rule 17.1, and in support of its request, the responsible entity advises that:

1. the Trading Halt is requested pending an update from RDC on its assessment of the NSW Premier's Announcement in respect of Covid-19 detailing cessation of "non-essential services" on hotels;
2. it requests that the Trading Halt remain in place until the earlier of such time as it makes an announcement to the market and the commencement of trading on Wednesday 25 March 2020; and
3. it is not aware of any reason why the Trading Halt should not be granted or any other information necessary to inform the market about the Trading Halt.
