Internal restructure of shareholdings of David Ahmet

MotorCycle Holdings Limited (ASX: MTO) has been advised by its Managing Director, Mr David Ahmet, that he has undertaken a restructure of the shares in the Company that he holds a relevant interest and voting power in.

Mr Ahmet currently holds a relevant interest and voting power in 18.29% of the Company and will, after the restructure, continue to hold the same relevant interest and voting power.

Mr Ahmet has transferred 6,300,000 shares (10.21% of the Company) currently held by Kenlake Pty Limited ATF the Ahmet Family Trust to Greenslide Pty Ltd, a company controlled by Mr Ahmet.


