Cleansing Notice Under Section 708a(5)(E) Of The Corporations Act 2001

As announced on 6 April 2020, Clean Seas Seafood Limited (ASX:CSS) (**Company**) has entered into an agreement with GCI CSS (Hofseth & Nevera) LLC (**Subscriber**), pursuant to which the Subscriber has agreed to subscribe for a total of 10,000,000 fully paid ordinary shares in the capital of the Company (**Shares**), which are to be issued across two tranches.

On 9 April, 4,000,000 Shares were issued to the Subscriber at the issue price of \$0.50 per Share (**Tranche 1 Shares**).

The Company confirms that:

- (a) the Tranche 1 Shares were issued without disclosure to the Lenders under Part 6D.2 of the *Corporations Act 2001* (Cth) (**Corporations Act**);
- (b) this notice is being given under section 708A(5)(e) of the Corporations Act;
- (c) as at the date of this notice, the Company has complied with:
 - (i) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
 - (ii) section 674 of the Corporations Act; and
- (d) as at the date of this notice, there is no excluded information of the type referred to in sections 708A(7) and 708A(8) of the Corporations Act.
