#### SETTLEMENT OF INSTITUTIONAL ENTITLEMENT OFFER

**Brisbane, Australia and Carlsbad, Calif.** – <u>ImpediMed Limited</u> (ASX: IPD) (**ImpediMed** or the **Company**) is pleased to announce that settlement of ~\$9.3M under the institutional component of the Entitlement Offer announced on Thursday, 2 April 2020 has occurred today. A further amount of ~\$0.7M relating to entitlements of a large existing shareholder is expected to settle shortly.
