Answer: No. The Company has taken action to dramatically reduce its operating and capital expenditure for the next six months. The Company is directing its cash resources towards getting the necessary project approvals.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The company is in discussion with potential equity providers to assist with the development of its project. It expects to raise equity at the end of the next quarter once it has received the necessary project approvals from Council and the EPA. These approvals are currently being reviewed by the Authorities and the Company does not foresee any problems. The company believes it will be successful.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes. Its main objective is to raise \$54 million to develop its initial magnesium plant. The Company has received interest from debt and equity providers to provide this funding.
