This facility is with a US Life Insurance Company and the terms are typical for a secured loan of this nature with a maturity date of 1 February 2022 + extension options. The year end interest rate is 5.65%. The loan is secured by charges over the property.

New Zealand Facility

This facility is with Bank of New Zealand (BNZ) and Industrial and Commercial Bank of China (ICBC) and the terms are typical for a secured loan of this nature with a maturity date of 22 October 2021. The interest rate is 2.4% margin on BKBM rate. The loan is secured by charges over the NZ properties.
