Eildon Capital Fund – Admission and Commencement of Official Quotation

Description

Eildon Capital Limited (the 'Company') is currently admitted to the Official List of ASX Limited ('ASX') and trades under the ASX Code EDC.

On 20 April 2020, security holders of the Company approved resolutions to staple ordinary shares in the Company to units in a newly established fund, Eildon Capital Trust (the 'Trust'), to create stapled securities ('Stapling Transaction').

After the implementation of the Stapling Transaction, each existing security holder of the Company will hold a new stapled security comprised of one fully paid ordinary share in the Company and one fully paid ordinary unit in the Trust ('Stapled Securities').

The Trust is expected to be admitted to the Official List of ASX either on the evening of Friday, 24 April 2020 or prior to trading commencing on Monday, 27 April 2020.

Official quotation of the Stapled Securities is expected to commence on a normal (T+2) settlement basis on Monday, 27 April 2020 at which point the new stapled entity will trade as Eildon Capital Fund.
