Net Asset Value as at 24 April 2020

The weekly estimated unaudited net asset value (**NAV**) before withholding tax as at 24 April 2020 was \$1.24* per unit.

If estimated tax on unrealised portfolio gains or losses were recognised, the weekly estimated unaudited post tax net asset value as at 24 April 2020 would be \$1.12* per unit.

Calculation of weekly NAV

This weekly unaudited NAV estimate has been calculated by reference to the Fund's most recent estimated unaudited monthly NAV at 31 March 2020 (being \$1.33 per unit on a pre-tax basis and \$1.20 per unit on a post-tax basis which applied an AUD:USD foreign exchange rate of 0.6131), adjusting for changes in the AUD:USD foreign exchange rate.

These estimates may not take into account all intra-monthly accruals, which are incorporated in the monthly NAV updates.

The applicable AUD:USD foreign exchange rate applied in calculating the estimated unaudited NAV as at 24 April 2020 was 0.6371.
