Answer: Yes, given the Company is an exploration company and not generating any revenue (other than interest income) it is expected that it will continue to have negative operating cash flows for the time being.	
2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
Answer: The Company may contemplate a further fundraising based upon ongoing satisfactory exploration results. The Company also retains the majority of its placement capacity under listing Rule 7.1 and 7.1A. In addition, the Company is eligible for the Federal Government's cash boost of \$100,000 of which the first payment of \$27,000 was received in April 2020. The Company has also qualified for an EIS drilling grant of \$125,000 for its Illaara Central Project.	
3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?	

Answer: The Company believes that it is able to continue its current operations and business objectives for the reasons outlined in questions 1 and 2. In addition, the formula based estimated expenditure in Item 8 above calculates theoretical expenditure of \$734,000 for the June 2020 quarter. Expenditure in the March 2020 quarter is not reflective of expenditure for the June 2020 quarter with our exploration requirements expected to be met from available cash and expected receipts as described in question 2 above.
