Gooroo Ventures Limited (“Gooroo” or the “Company”) is pleased to announce that the Company has issued 263,158 ordinary shares to Norvest Projects Pty Ltd (“Norvest”) following conversion of 150,000 Convertible Notes by Norvest. Norvest has elected to convert instead of redemption and the Company has decided to accommodate the request. Please refer to Appendix 3B dated 18 December 2019 for details of the convertible note. All of the convertible notes issued under the same Appendix 3B have now been converted or redeemed.

These shares are subject to a holding lock due to the Company’s securities have been suspended for more than 5 trading days in the last 12 months. The holding lock will be released upon the anniversary of the issue date or upon the release of a cleansing prospectus by the Company, whichever earlier.
