## Reminder regarding voting at Atlas Arteria's upcoming AGM

In advance of the upcoming Annual General Meetings of Atlas Arteria Limited and Atlas Arteria International Limited (together, "Atlas Arteria" (ASX:ALX)) to be held at **10.00am (Melbourne time) on Tuesday 19 May 2020** ("AGMs"), Atlas Arteria reminds Shareholders that the meeting will be held virtually, with no physical attendance at the meeting.

Shareholder questions can be posted online during the AGMs, however, it will not be possible to cast votes. As a reminder, those wishing to vote will need to submit their proxy forms by no later than **10.00am (Melbourne time) on Sunday 17 May 2020** in accordance with the instructions in the Notice of Meeting documents.

Where a Shareholder appoints someone other than the Chairs as their proxy:

- by default the Chair of the relevant meeting will be taken to have been appointed as proxy for that Shareholder
- in this circumstance, the Chairs will be directed by the voting preferences (if any) provided in the Proxy Form
- where a Proxy Form does not direct the proxy on how to vote, the Chairs intend to cast that Shareholder's votes in favour of the relevant resolutions as disclosed on the Notice of Meeting documents.

Shareholders are encouraged to ask questions before the AGMs by completing the corresponding space provided in the Proxy Form or by emailing <a href="ALXcompanysecretary@computershare.com.au">ALXcompanysecretary@computershare.com.au</a>. We ask that you submit these questions by **10.00am (Melbourne time) on Monday 11 May 2020** so that we can consider them and post responses to our website for the benefit of all Shareholders prior to the voting deadline.
