Summary of material terms of share rights

Grant	Share rights granted as part payment of remuneration. The value of each share right was calculated using the volume-weighted average market price (VWAP) of Shares over the 10 trading days from 26 March 2020 to 8 April 2020 inclusive, being \$2.0093.
Entitlement	A share right is a right to one fully paid ordinary share in DHG, or in certain circumstances at the discretion of DHG, a right to a cash payment in lieu of shares, subject to satisfaction of the applicable vesting conditions. Share rights do not carry voting or dividend rights. Once share rights have vested and been exercised, the shares issued or transferred will rank equally with ordinary shares in DHG for any dividends. Dealings with share rights (including transfers) are prohibited, unless the DHG board determines otherwise or the dealing is required by law and the holder has provided satisfactory evidence to DHG of that fact.
Vesting conditions	Vesting of a share right is subject to the holder remaining employed by DHG (or a member of the Domain Group) between the date of grant of the share right (7 May 2020) and the vesting date (7 November 2021).
Exercise	Vested share rights may be exercised within three possible exercise windows, subject to DHG's Securities Trading Policy. The three exercise windows are the 10 trading day periods starting the trading day immediately after: • DHG's annual general meeting (anticipated to be in November 2021); • DHG's half-year results being announced (anticipated to be in February 2022); and • DHG's full-year results being announced (anticipated to be in August 2022). If a share right is not exercised in any of the above exercise windows, it will be automatically exercised within an automatic exercise period (five trading days immediately after the end of the third exercise window above), unless the holder gives notice that they do not wish the share right to be exercised.
Expiry	Share rights (whether vested or unvested) will expire and no longer be exercisable on the expiry date (the day immediately after the end of the automatic exercise period). A holder does not receive a cash payment in lieu of a share right that expires unexercised.
Cessation of employment	If a holder's employment with DHG (or a member of the Domain Group) ceases prior to the vesting date the DHG board may in its discretion determine that some or all of the holder's unvested share rights lapse, are forfeited, vest (immediately or subject to conditions) or are only exercisable for a prescribed period and then will lapse.
